The position may have a variety of daily and periodic responsibilities based on the department's business need and requires a strong working knowledge of tax regulations, financial services industry rules, processes, systems, and controls.

- 3-5 years of experience in the financial services industry is required. Experience in tax reporting, corporate actions, cost basis, account opening, estates and/or retirement is preferred.
